## 1. Information We Collect

We may collect the following types of information:

### A. Personal Information You Provide:

- \* Name, email address, phone number, and mailing address.
- \* Payment and billing information when purchasing memberships or making donations (processed through secure third-party payment processors; we do not store payment card details).
- \* Information you provide when signing up as an independent contractor or affiliate, such as wallet addresses for USDT payouts.

### B. Automatically Collected Information:

- \* IP address, browser type, device information, and operating system.
- \* Website usage data (pages visited, time spent, referring URLs) collected via cookies and analytics tools.

### C. Information from Third Parties:

- \* We may receive referral data or fundraising performance information from organizations or partners working with us.

## 2. How We Use Your Information

We may use your information for purposes including:

- \* Processing memberships, donations, and transactions.
- \* Managing referral programs and affiliate payouts.
- \* Providing customer support and responding to inquiries.
- \* Improving website functionality, security, and user experience.

- \* Sending promotional or informational emails (you may opt-out at any time).
- \* Complying with legal obligations or enforcing terms of service.

### 3. Sharing Your Information

We do not sell or rent your personal information. We may share information with:

- \* Service Providers: Payment processors, website hosting, email marketing services, and analytics providers.
- \* Fundraising Organizations: Limited donor or participant information as needed to track fundraising campaigns.
- \* Legal Compliance: When required by law, regulation, or legal process.

### 4. Cookies and Tracking Technologies

We use cookies and similar technologies to enhance user experience, analyze website traffic, and track referral activity. You can manage cookie settings through your browser; however, disabling cookies may limit site functionality.

### 5. Data Security

We implement reasonable administrative, technical, and physical safeguards to protect your personal data. However, no method of transmission or storage is 100% secure, and we cannot guarantee absolute security.
